**REQUESTED ACTION:** The Zoning Administrator will consider:

Pursuant to Section 12.26-K of the Los Angeles Municipal Code, a Director Planning Determination as to whether the Department of Building and Safety erred or abused their discretion in issuing Building Permit No. 15019-20000-00371 to demolish an existing single-family dwelling and detached garage. Appellant has also requested that the following permits be placed on hold: Building Permit No. 14010-20000-03880 issued for construction of a new two-story, single-family dwelling with attached garage; Building Permit No. 15030-20000-00829 issued for grading, and Building Permit No. 15047-20000-00411 issued to build a new swimming pool and spa.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision

maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**Exhaustion Of Administrative Remedies:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
