PROPOSED PROJECT:	The construction, use, and maintenance of three small lot homes in conjunction with a small lot subdivision. Each small lot home will be three stories with a roof deck, with heights ranging from 34'-6" to approximately 43' and will have two covered parking spaces.		

## REQUESTED The Deputy Advisory Agency will consider: ACTION:

- Pursuant to the Los Angeles Municipal Code Sections 17.53 and 12.22-C,27, Parcel Map No. AA-2016-4276-PMLA-SL to permit the subdivision of one (1) lot into three (3) small lots, in accordance with the Small Lot Ordinance No. 176,354, located on an approximately 7,499 square-foot site in the RD2-1VL Zone;
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the

environment and which shall, therefore, be exempt from the provisions of CEQA. On November 8, 2016, a Categorical Exemption, ENV-2016-4277-CE, Class 15 for Minor Land Divisions, was issued for the project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
