Pursuant to Section 12.26-K of the Los Angeles Municipal Code, a Director of Planning Determination as to whether the Department of Building and Safety erred or abused its discretion in issuing the following Permits: Building Permit No. 12010-30000-00748 issued on March 24, 2015, for a new recreation room with exterior stairs; Building Permit No. 1302030000-00849 issued on March 24, 2015, for two retaining walls, and; Building Permit No. 14030-30000-04398 issued on March 24, 2015, for Grading for the retaining walls and site preparation.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
