REQUESTED The Zoning Administrator will consider: **ACTION:**

- 1. Pursuant to the provisions of Section 12.24.W.9 of the Los Angeles Municipal Code, a Conditional Use to allow a church in an existing Historic Cultural Monument (HCM #258) building in a R3-1-O-HPOZ zone in conjunction with exterior and interior improvements.
- 2. Pursuant to the provisions of Section 12.24.W.37 of the Los Angeles Municipal Code, a Conditional Use to allow the construction, use and maintenance of a surface parking lot in a R3-1-O-HPOZ zone with 44 parking spaces.
- 3. Pursuant to Article III, Section I, Class 3 (Conversion of Small Structures) and Class 32 (In-Fill Development) of the City of Los Angeles CEQA Guidelines, the above

referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
