PROPOSED PROJECT:

The proposed project involves the continued sale and dispensing of a full line alcoholic beverages for on-site consumption in conjunction with a 175 square-foot expansion of an existing 1,720 square-foot restaurant, for a total of 1,877 square feet, with an 139 square-foot outdoor patio (within the public right-of-way), with 46 indoor seats and 24 outdoor seats (within the public right-of-way), for a total of 70 seats, with hours of operation from 10:00 a.m. to 2:00 a.m., daily.

REQUESTED ACTION(S):

The Zoning Administrator shall consider:

- An Exemption from CEQA, pursuant to State CEQA Guidelines Section 15305, and City CEQA Guidelines Class 5, Category 23, that there is no substantial evidence demonstrating that an exception to the categorical exemption pursuant to State CEQA Guidelines Section 15300.2, applies; and
- 2. Pursuant to Los Angeles Municipal Code Section 12.24-M, a Plan Approval to allow the continued sale and dispensing of a full line alcoholic beverages for on-site consumption in conjunction with a 175 square-foot expansion of an existing 1,720 square-foot restaurant, for a total of 1,877 square feet, with an 139 square-foot outdoor patio (within the public right-of-way), with 46 indoor seats and 24 outdoor seats (within the public right-of-

way), for a total of 70 seats, with hours of operation from 10:00 a.m. to 2:00 a.m., daily, in the C1-1D Zone. The applicant is requesting the following modifications ZA-2009-4074-CUB:

No portable bar(s) or any bar within the outside patio shall be permitted on the premises. |
| Condition No. 35: | Deleting the condition - There shall be no sale or service of alcoholic beverages in the outdoor patio without accompanying meal service. |

Recommendation Reports are hyperlinked to the case numbers on the agendas. Please note that Recommendation Reports <u>are not</u> prepared for Hearing Officer or Zoning Administrator hearings.

TESTIMONY AND CORRESPONDENCE - Your attendance is optional; oral testimony can only be given at the public hearing and may be limited due to time constraints. Written testimony or evidentiary documentation may be submitted prior to the hearing. Decision-makers such as Associate Zoning Administrators or Commissions function in a quasi-judicial capacity and therefore, cannot be contacted directly. Any materials submitted to the Department or Commission become City property and <u>will not</u> be returned. This includes any correspondence or exhibits used as part of your testimony.

REQUIREMENTS FOR SUBMISSION OF MATERIALS - Written testimony may be submitted via email, in person or by U.S. mail to the staff identified on the front of this page. Correspondence should be presented on letter size ($8 \frac{1}{2} x 11^{\circ}$) or legal size ($8 \frac{1}{2} x 14^{\circ}$) paper. All oversized exhibits <u>must be folded</u> to fit into a legal-sized folder. Plans (i.e. site plans, floor plans, grading plans) must be presented on paper size not smaller than ledger size ($11^{\circ} x 17^{\circ}$). The case number must be written on all communications, plans and exhibits. To the extent possible, please <u>also</u> submit all materials electronically (flash drive, CD or via email).

Regular Submissions

 <u>Matters before an Associate Zoning Administrator (AZA) or Hearing Officer:</u> Written materials not limited as to volume must be <u>received</u> no later than five (5) days prior to the hearing date. Provide an original plus (3) copies, and follow the size guidelines above.

Rebuttal Submissions - All written materials in response to a Recommendation Report and/or additional comments must be submitted no later than **48 hours** before the hearing date. Submissions, including exhibits, shall not exceed ten (10) pages.

Day of Hearing Submissions - Submissions less than 48 hours prior to, and including the day of the hearing, must not exceed two (2) written pages, including exhibits. Photographs do not count toward the page limitation. Notwithstanding, the Associate Zoning Administrator or Hearing Officer may deviate from this requirement at their discretion.

Non-Complying Submissions - Submissions that do not comply with these rules will be stamped *"File Copy. Non-complying Submission"*. Non-complying submissions will be placed into the official case file, but they will not be delivered to, or considered by the Commission, Associate Zoning Administrator or Hearing Officer. Notwithstanding, the Associate Zoning Administrator or Hearing Officer may deviate from this requirement at their discretion.

EXHAUSTION OF ADMINISTRATIVE REMEDIES AND JUDICIAL REVIEW - If you challenge these agenda items in court, you may be limited to raising only those issues you or someone else raised at the public hearing agenized here, or in written correspondence on these matters delivered to this agency at or prior to the public hearing. If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.5, the petition became final pursuant to California Code of Civil Procedure Section became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.
