DIRECTOR'S REPORT AND COMMISSION BUSINESS

Debbie Lawrence, Senior City Planner made the following announcements:

- On February 14, 2018, the City Council adopted the Comprehensive Fee Study as amended to include a fifty percent subsidy for single family residential home additions that require a Coastal Development Permit.
- On February 13, 2018, the Planning and Land Use Management Committee instructed the
 Office of the City Attorney to prepare an updated Permanent Supportive Housing
 Ordinance. The ordinance will have additional standards for height and setbacks on
 qualifying projects that are located within the RD1.5 Zone. The Planning and Land Use
 Management Committee also instructed the Office of the City Attorney to prepare for former
 legality the Interim Hotel Conversion Ordinance.
- On February 19, 2018, the Department of City Planning added two new staff members to the External Affairs Unit as Neighborhood Liaisons. This section now has a total of three liaisons and the department will be able to coordinate outreach efforts based on regions within the various neighborhood councils and stake holders.
