Commissioner Harootoonian put forth the actions below in conjunction with the approval of the following project:

The expansion of an existing 25,730 square-foot LA Fitness health club/gym into an adjacent 8,227 square-foot retail space. The newly expanded facility would include approximately 33,957 square feet of floor area. The project would include 172 automobile parking spaces. Proposed hours of operation are from 5:30 a.m. to 11:00 p.m. Monday through Thursday; 5:00 a.m. to 10:00 p.m. Friday and 8:00 a.m. to 8:00 p.m. Saturday and Sunday.

- 1. Determine based on the whole of the administrative record, the Project is exempt from CEQA pursuant to State CEQA Guidelines, Section 15301, 15305 and City CEQA Guidelines Class 5, Category 13, and that there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies;
- 2. Approve and recommend that the City Council adopt, pursuant to Los Angeles Municipal Code (LAMC) Section 12.32 F, a Zone Change from MR2-1 and P-1 to (T)(Q)C2-1;
- 3. Approve, pursuant to LAMC Section 12.37 I.3, a Waiver of Dedication and Improvements;

- 4. Adopt the Conditions of Approval including Staff's Technical Modifications dated February 26, 2018; and
- 5. Adopt the Findings.
