ITEM NO. 1

DIRECTOR'S REPORT AND COMMISSION BUSINESS

Debbie Lawrence, Senior City Planner reported on the following items of interest:

- On May 7, 2018, the Budget and Finance Committee recommended approval for the creation of an additional Deputy Planning Director position to oversee Community Planning. The position would be fully funded for 9 months from the Long Range planning Fund. In addition, the Committee recommended approval for the creation of a Specific Plan Maintenance Unit which would focus on updating specific plans.
- On April 15, 2018, the Los Angeles Chapter of the American Planning Association announced the winners of the 2018 Planning Awards. The Planning Department received the award for Comprehensive Plan Large Jurisdiction for the South LA and Southeast LA Community Plans and the City received the award for Social Change and Diversity for the newly adopted cannabis ordinance. The Ceremony will take place at the Santa Monica College of Performing Arts in June.
- In April the Department launched its second planning 101 series. It focused on the develop process and it was prepared in collaboration with the Department of Neighborhood Empowerment. The training sessions were held in sever areas of the City with over 400 attendees.
- Venice Coastal Program update the last of the four community workshops addressing sea level rise and coastal adaptation strategies for the Venice Coastal Zones scheduled for May 22, 2018, at the Westminster Elementary School in Venice.

President Margulies recessed the meeting at 5:58 p.m. to allow the appellants time to review the applicant's submittal. The meeting was reconvened at 6:09 p.m. with all Commissioners present.

MOTION:

Commissioner Margulies put forth the actions below in conjunction with the approval of the following project:

The demolition of a one-story, 688 square-foot, single-family dwelling located at 927 W. Marco Place (Lot 24) and the relocation of one-story, 1,256 square-foot, single-family dwelling located at 925 W. Marco Place (Lots 22 & 23) to 927 West Marco Place (Lot 24); the structure is to be preserved and a two-story addition will be constructed to the rear, resulting in a two-story, 2,335square-foot single-family dwelling with an attached, two-car garage. The project includes the construction of one, two-story, 2,337 square-foot, single-family dwelling with a rooftop deck and an attached two-car garage at 925 West Marco Place (Lot 22) and one, two-story, 2,104 squarefoot, single-family dwelling with a rooftop deck and an attached two-car garage at 927 West. Marco Place (Lot 23). Each single-family dwelling will provide a total of three parking spaces onsite.

- 1. Determine based on the whole of the administrative record, that the Project is exempt from CEQA pursuant to CEQA Guidelines, Section 15303, 15331 and 15332, and Article III, Section 1, Class 3, Category 1 of the City CEQA Guidelines; and there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies;
- Deny the appeal and sustain the Planning Director's determination to approve, a 2. Coastal Development Permit pursuant to Los Angeles Municipal Code (LAMC) Section 12.20.2, a Project Permit Compliance Review pursuant LAMC Section 11.5.7, and a Mello Act Compliance Review pursuant to Government Code Sections 65590 and 65590.1, for the project; and
- Adopt the Conditions of Approval and Findings by the Planning Director. 3.
