The proposed project includes a Specific Plan Project Permit Compliance review for the installation of two (2) new emergency standby generators and 6-foot 4-inch security screen on property zoned CR(PKM)-1. The generators will be self-contained units enclosed within a decorative louvered screened fence. The generators are proposed to only operate during power outages and periodic maintenance testing. The generators are proposed to front Wilshire Boulevard and stepped back at a minimum of 20 feet from the existing northerly property line.
