The continued sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with an existing 1,600 square-foot restaurant and a 240 square-foot outdoor patio with 62 indoor seats and 18 outdoor seats and a single shuffleboard and hours of operation from 11:00 a.m. to 2:00 a.m. Monday through Friday and 9:00 a.m. to 2:00 a.m. Saturday and Sunday.

- 1. Determine based on the whole of the administrative record, that the Project is exempt from CEQA pursuant to Section 1, Class 5, Category 23, of the CEQA Guidelines, and there is no substantial evidence demonstrating that an exception to a categorical exception pursuant to CEQA Guidelines, Section 15300.2 applies;
- 2. Grant the appeal in part and sustain in part the determination of the Zoning Administrator to approve plans, pursuant to Section 12.24 M of the Los Angeles Municipal Code to allow the continued sale and dispensing of a full line of alcoholic beverages for onsite consumption in conjunction with an existing restaurant;
- 3. Adopt the Conditions of Approval as modified by the Commission, including a revision to Exhibit A; and
- 4. Adopt the Findings as amended by the Commission.
