The rehabilitation of a 1,623 square-foot one- and two-story Contributing structure and the construction of two new residential structures and a carriage house on a double corner lot in the Angelino Heights Historic Preservation Overlay Zone (HPOZ).

- 1. Determine based on the whole of the administrative record, that the Project is exempt from CEQA pursuant to Article 19, Section 15331, Class 31 (historic resources) and the City CEQA Guidelines, Article III, Section 1, Class 3 Category 2 (multi-family); Article III, Section 1, Class 3 Category 6 (accessory structures), of the CEQA Guidelines, and there is no substantial evidence demonstrating that an exception to a categorical exception pursuant to CEQA Guidelines, Section 15300.2 applies;
- Grant the appeal in part, and deny the appeal in part;
- 3. Sustain the Planning Director's determination to approve a Certificate of Appropriateness, pursuant to LAMC Section 12.20.3 K, and the Angelino Heights HPOZ, for the rehabilitation of a 1,623 square-foot one- and two-story Contributing structure and the construction of two new residential structures and a carriage house on a double corner lot as modified by the Commission; and
- 4. Adopt the Conditions of Approval of the Planning Director, as modified by the Commission;
- 5. Adopt the Findings of the Director of Planning, as amended by Staff's Technical Modification dated July 11, 2018.
