Demolition of three (3) one (1) unit buildings; subdivision of one (1) lot comprising of 7,168 net square feet into four (4) small lots; and the construction, use and maintenance of four (4) three-story, single-family dwellings on each small lot.

REQUESTED ACTION(S):

- 1. The Advisory Agency shall consider an Exemption from CEQA pursuant to State CEQA Guidelines, Article 19, Section 15315 (Minor Land Divisions) and Section 15332 (Urban Infill), and there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies.
- 2. Pursuant to Sections 17.50 and 12.22 C.27 of the Los Angeles Municipal Code (LAMC), a Preliminary Parcel Map for the subdivision of one (1) lot into four (4) small lots.
- 3. Pursuant to Section 17.53 of the LAMC, a height adjustment of up to 20% to allow an overall height of 34 feet in lieu of the otherwise permitted maximum height of 30 feet.

An original plus three (3) copies must be submitted prior to, or at the hearing. To the extent possible, please <u>also</u> submit all materials electronically (flash drive, CD or via email). Materials must be presented on letter size (8 ½ " x 11") or legal size (8 ½ " x 14") paper. All oversized exhibits <u>must be folded</u> to fit into a legal-sized folder. Plans (i.e. site plans, floor plans, grading plans) must be presented on paper size not smaller than ledger size (11" x 17"). The case number must be written on all communications, plans and exhibits.

EXHAUSTION OF ADMINISTRATIVE REMEDIES AND JUDICIAL REVIEW - If you challenge these agenda items in court, you may be limited to raising only those issues you or someone else raised at the public hearing agenized here, or in written correspondence on these matters delivered to this agency at or prior to the public hearing. If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.
