- Approved, pursuant to Section 12.24 X.7 of the Los Angeles Municipal Code (LAMC), a Zoning Administrator's 2. Adjustment to permit a 6-foot fence in lieu of the maximum height of 3-feet, 6-inches, the maximum height allowed in the RE9 Zone pursuant to LAMC 12.21 C.1(g).

Be advised that the Commission may RECONSIDER and alter its action taken on items listed on the meeting agenda at any time during this meeting or during the next regular meeting, in accordance with the Commission Policies and Procedures and provided that the Commission retains jurisdiction over the case. If a Commission meeting is cancelled or adjourned due to lack of quorum, all remaining agenda items shall be continued to the next regular meeting or beyond, as long as the continuance is within the legal time limits of the case or cases.
