Commissioner Stern put forth the actions below, in conjunction with the disapproval of the following project:

Plans to modify the Conditions of Approval and site plan for a Yard Variance originally granted on December 20, 1995, for an existing multi-family residential building and detached single-family dwelling over two lots.

- 1. Deny the appeal and sustain the Zoning Administrator's determination to deny:
 - a. Pursuant to Section 12.27 U.2 of the Los Angeles Municipal Code, a Reduction of Site request to remove Lot 3 from the legal description in order to reduce the project site from 14,000 squarefeet to 7,000 square-feet for an existing project site containing 13 dwelling units; and
 - b. A request to modify Condition No. 4 of Case No. ZA-1995-744-YV, to reduce the required 22 parking spaces to 6 parking spaces for an approved 12-unit multi-family residential building and a detached single-family dwelling on an existing 14,000 square-foot site
- 2. Adopt the findings of the Zoning Administrator.
