## PROPOSED PROJECT:

A Vesting Tentative Tract for the merger and re-subdivision of two lots into one ground lot and 26 condominium units for the construction of a 26-unit multi-family residential building on a 14,612 square-foot site in the [Q]R3-1 Zone.

The Commission may consider, based on the whole of the administrative record, that the Project is exempt from CEQA pursuant to State CEQA Guidelines, Section 15332 (Class 32), and that there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies;
