### MOTION:

Commissioner Schultz put forth the actions below in conjunction with the approval of the following project:

A Vesting Tentative Tract for the merger and re-subdivision of two lots into one ground lot and 26 condominium units for the construction of a 26-unit multi-family residential building on a 14,612 square-foot site in the [Q]R3-1 Zone.

1. Determine, based on the whole of the administrative record, that the Project is exempt from CEQA pursuant to State CEQA Guidelines, Section 15332 (Class 32), and that there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to CEQA Guidelines, Section 15300.2 applies;

- 2. Deny the appeal and sustain the January 11, 2019, Deputy Advisory Agency determination to approve, pursuant to Section 17.03, of the Los Angeles Municipal Code, a Vesting Tentative Tract for the merger and re-subdivision of two lots into one lot and a 26-unit residential condominium building; and
- 3. Adopt the Conditions of Approval and findings of the Deputy Advisory Agency.
