4750 W. Wilshire Boulevard:

The proposed project includes a Specific Plan Project Permit Compliance review for additions and renovations to an existing 3-story commercial building located in the CR(PkM)-1 and RD3-1 Zones. The proposed scope of work includes a new 4,000 square-foot open terrace located on the second level, and three new permanent shade structures (12 feet in height) located at the southwest corner of the existing commercial structure. The project will include exterior landscape renovations (addition of trees, shrubs and seating areas), three permanent shade awnings, trellis structure, ADA access ramp, stairs and two wayfinding signs.
