Commissioner Bates put forth the actions below in conjunction with the approval of the following project.

Construction of a new canopy for nine new pumps at an existing automobile refueling station and the construction, use, and maintenance of a new 2,900 square foot food mart.

- Determine based on the whole of the administrative record, the Project is exempt from CEQA pursuant to State CEQA Guidelines, Article 19, Section 15332 (Infill Development) and City CEQA Guidelines, Section 1, Class 32 (Infill Development), and that there is no substantial evidence demonstrating that an exception to a categorical exemption pursuant to State CEQA Guidelines Section 15300.2, applies;
- 2. Deny the appeal and sustain the Zoning Administrator's December 7, 2018 determination to approve, pursuant to Section 12.24 W.27 of the Los Angeles Municipal Code (LAMC), a Conditional Use Permit to allow deviations from the Commercial Corner Standards to allow 24 hour operation in lieu of 7:00 a.m. to 11:00 p.m.;
- 3. Dismiss a Conditional Use Permit, pursuant to Section 12.24 W.1 of the LAMC, to allow off-site sales of beer and wine from 6:00 a.m. to 2:00 a.m.;
- 4. Adopt the Conditions of Approval as modified by the Commission;
- 5. Adopt the Findings as amended by the Commission, including Staff's Technical corrections.
