  - i) **DIR-2019-3188-DRB-SPP-MSP, 2669 Larmar Road (CD 4)** – Partial demolition of 611 square feet and the construction of a 2,183 square-foot addition to an existing two-story, 2,568 square-foot, single-family dwelling which includes an existing 398 square-foot two-car garage and a new pool. The project includes 2,860 square feet of hardscape on an approximately

12,634 square-foot lot. The proposed structure has a maximum height of approximately 29 feet and six (6) inches. The project is in the Outer Corridor and is subject to the Baseline Hillside Ordinance adopted on March 17, 2017. The project is downslope from Larmar Road and downslope from Mulholland Drive, and visible from Mulholland Drive. The project does not propose the removal of any protected trees. The project does not require a haul route.

Grading – Cut: 143 Cubic Yards (CUYD), Fill: 70 CUYD, Export: 73 CUYD, Import: 0 CUYD.

- ii) **ZA-2019-4079-ZAD-DRB-SPP-MSP, 4621 Saltillo Street APN: 2190-015-007 (CD 3)** – Construction of a new, two-story, single-family dwelling with a 1,238 square-foot basement (including a 482 square-foot ADU) and a 578 square-foot four-car garage. The structure shall include 2,524 square feet of Residential Floor Area on an approximately 5,162 square-foot lot. Also included is a 347 square-foot swimming pool and four (4) new retaining walls. The proposed structure has a maximum height of 45 feet. The project is located in the Girard Tract Specific Plan, the Mulholland Outer Corridor, and subject to the Baseline Hill Ordinance adopted on March 17, 2017. The project is upslope from Saltillo Street and downslope from Mulholland Drive, and not visible from Mulholland Drive. The project does not propose the removal of any protected trees. The project does not require a haul route.

The applicant is also seeking a Zoning Administrator's Determination to allow a reduced roadway and to allow four retaining walls in lieu of the two allowed per code.

**OPEN MEETINGS** - The DRB shall provide an opportunity in open meetings for the public to address items of interest to the public that are within the subject matter jurisdiction of the DRB. The Chair of the DRB may allocate the number of speakers per subject, the time allotted on each subject, and the time allotted to each speaker. Under the provisions of the Brown Act (Gov. Code Sec. 54959-54960), the Mulholland Scenic Parkway Specific Plan Design Review Board is a "legislative body" and must:

1. Conduct all quorum meetings in public; and
2. Post all agenda items or issues considered for discussion seventy-two (72) hours before public meetings. Public notices are posted at the Offices of the Planning Department and the Planning Department Website. Click on Meeting/Hearing/Environmental.

**FILE REVIEW** - The complete file is available for public inspection between the hours of 8:30 a.m. to 4:00 p.m., Monday through Friday. Please call or email the staff identified on the front page, at least three (3) days in advance to assure that the files will be available. Appointments are encouraged. **Files are not available for review the day of the hearing.**

**TESTIMONY AND CORRESPONDENCE** - Your attendance is optional; oral testimony can only be given at the public hearing and may be limited due to time constraints. Written testimony or evidentiary documentation may be submitted prior to, or at the hearing. Decision-makers such as Associate Zoning Administrators function in a quasi-judicial capacity and therefore,

cannot be contacted directly. Any materials submitted to the Department become City property and will not be returned. This includes any correspondence or exhibits used as part of your testimony.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES AND JUDICIAL REVIEW** - If you challenge these agenda items in court, you may be limited to raising only those issues you or someone else raised at the public hearing agenzied here, or in written correspondence on these matters delivered to this agency at or prior to the public hearing. If you seek judicial review of any decision of the City pursuant to California Code of Civil Procedure Section 1094.5, the petition for writ of mandate pursuant to that section must be filed no later than the 90th day following the date on which the City's decision became final pursuant to California Code of Civil Procedure Section 1094.6. There may be other time limits which also affect your ability to seek judicial review.

**ACCOMMODATIONS** - As a covered entity under Title II of the Americans with Disabilities Act, the City of Los Angeles does not discriminate on the basis of disability. The hearing facility and its parking are wheelchair accessible.
