ACTIONS: The Deputy Advisory Agency shall consider:

> 1. Pursuant to Section 17.00 of the Los Angeles Municipal Code consideration of a Vesting Tentative Tract Map.

- 2. Pursuant to Section 17.03 an adjustment to allow a standard 15 foot front yard setback in lieu of an 18 foot building line after a two foot dedication on Victory Boulevard.
- 3. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, consideration of the Mitigated Negative Declaration (MND) for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.


