PROPOSED PROJECT:

The project involves the sale and dispensing of beer and wine only for on-site and off-site consumption in conjunction with a remodeled 2,150 square-foot restaurant accommodating 42 interior seats with hours of operation from 10:00 a.m. to 11:00 p.m. Sunday through Thursday and 10:00 a.m. to 12:00 a.m. Friday and Saturday. Hours of beer and wine only sales shall be from 11:00 a.m. Tuesday through Thursday and 10:00 a.m. Friday through Monday.

REQUESTED ACTIONS:

The Zoning Administrator will consider the following:

1) Pursuant to Los Angeles Municipal Code Section 12.24-W,1, a Conditional Use to allow the sale and dispensing of beer and wine only for on-site consumption in conjunction with a new restaurant within an existing building in the C2-1XLD Zone;

- 2) Pursuant to Los Angeles Municipal Code Section 12.24-W,27, a Conditional Use to allow hours of operation exceeding the maximum permitted hours of 7:00 a.m. to 11:00 p.m. at a minishopping center; and
- 3) Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall, therefore, be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
