**PROJECT** LOCATION: 4000 S. Bluff Place, legally described as: Lot: 1, Block: G, Tract: TR 432.

**PROPOSED** PROJECT:

The proposed project involves the repair of an existing, approximately 1,281-square-foot, fire-damaged, one-story single-family dwelling including the removal and replacement of fire-damaged roof, floor and wall framing with new matching roof, floor and wall framing, and the removal and replacement of fire-damaged interior and exterior finishes with new matching finishes, with a maximum height of 16'-9" (not to exceed the maximum height of the structure), located in the dual permit jurisdiction area of the Coastal Zone.

**REQUESTED** ACTION:

1. Pursuant to Section 12.20.2 of the Municipal Code, a Coastal Development Permit for the proposed repair of an existing, approximately 1,281-square-foot, one-story single-family dwelling including the removal and replacement of firedamaged roof, floor and wall framing with new matching roof, floor and wall framing, and the removal and replacement of fire-damaged interior and exterior finishes with new matching finishes, with a maximum height of 16'-9" (not to DIR-2015-3594-CDP Page 2

exceed the existing height of the structure), located in the dual permit jurisdiction area of the Coastal Zone.

2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of the California Environmental Quality Act (CEQA).

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
