**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. A Coastal Development Permit, pursuant to the provisions of Section 12.20.2 of the Los Angeles Municipal Code, to permit the construction of a 35-foot tall mixed-use building featuring 7,992 square feet of retail, 20,000 square feet of office, and one 800 square-foot dwelling unit, all sited on a 19,195 square-foot lot within the dual-jurisdiction area of the California Coastal Zone, and 2) Pursuant to Section 12.24-W,27 of the LAMC, a Conditional Use, to permit deviations from commercial corner establishment/mini-shopping center requirements by allowing on-site tandem parking otherwise not permitted by Section 12.22-A,23(a)(4)(i), and relief from the requirement to landscape all street frontages and perimeters as required by 12.22-A,23(a)(10)(i); and 3) Pursuant to the provisions of Section 11.5.7 of the LAMC, a Project Permit Compliance from the Venice Coastal Zone Specific Plan.
- 2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**Exhaustion Of Administrative Remedies:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
