**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. A Coastal Development Permit, pursuant to the provisions of Section 12.20.2 of the Los Angeles Municipal Code, for the proposed construction of a new 30-foot tall, 2,669 square-foot single-family dwelling located on a 7,463 square-foot lot zoned R2-1 within the single jurisdiction area of the California Coastal Zone, and 2) A Zoning Administrator's Determination, pursuant to the provisions of Section 12.24-X,7 to allow the construction and continued use of a wall, landscaping, and entry gates with a maximum height of 8 feet, all in lieu of the maximum 3-1/2 feet in height otherwise permitted in the front yard by Section 12.21-C,1(g) of the Code.
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**Exhaustion Of Administrative Remedies:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
