PROPOSED PROJECT:

The proposed sale of beer and wine only for on-site consumption in conjunction with the operation of a new 1,374 square foot restaurant with seating for 48 patrons (36 interior and 12 outdoor patio seats) with proposed hours of operation from 6 a.m. to 2 a.m., daily, located on the ground floor of the Garment Capitol Building.

REQUESTED ACTION:

- 1) Pursuant to Los Angeles Municipal Code Section 12.24-W,1, a Conditional Use to permit the sale and dispensing of beer and wine only for on-site consumption in conjunction with the operation of a 1,374 square foot restaurant with 131 square-foot patio in the M2-2D Zone:
- 2) Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall, therefore, be exempt from the provisions of CEQA.


