**PROJECT LOCATION:** 7616 W. Willow Glen Road (legally described as Tract: TR 10246, Lot: 19)

**PROPOSED PROJECT:** A three-parcel, single-family subdivision on a 49,079 gross square-foot site in the RE11-1 Zone. Proposed area of Parcel A, improved with an existing single family dwelling is proposed at 11,380 square feet; Parcel B at 18,965 square feet; and Parcel C at 18,734 square feet; Parcels B and C will be developed with single family dwellings at a future date. Existing dwelling on Parcel A to remain.

**REQUESTED ACTION:** The Deputy Advisory Agency shall consider:

Pursuant to Los Angeles Municipal Code (LAMC) Section 17.53, a Preliminary Parcel Map No. AA-2013-1999-PMLA, to permit a three-lot subdivision (with existing structure to remain on Parcel A) on a 49,079 square feet lot within the RE11-1 zone.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

**ADVICE TO PUBLIC:** The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
