REQUESTED ACTION: The Zoning Administrator will consider:

1. Pursuant to LAMC Section 12.27, a Variance to legalize an existing second dwelling unit otherwise not permitted in the R1 Zone by Section 12.08-A, and 2) a Zoning Administrator's Adjustment per Section 12.28 of the Los Angeles Municipal Code to allow a side yard of 4 feet 3 inches in lieu of the required 5-foot side yard and a rear yard of 8 feet in lieu of the 15-foot rear yard required by Section 12.08-C, and an 8-foot passageway in lieu of the 10-foot passage way required by Section 12.21-C,5 all in conjunction with the proposed legalizing of an existing guest house on a lot zoned R1-1.
2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

Advice To Public: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda. Review Of File: The file, including the application and the environmental assessment, are available for public inspection at this location between the hours of 8:00 a.m. to 4:00 p.m., Monday through Friday. Please call (213) 978-1318 several days in advance to assure that the files will be available. The files are not available for review the day of the hearing.
