PROJECT LOCATION: 20900 West Sesnon Boulevard

PROPOSED PROJECT: The revision of the layout and boundary of a previously approved tract (VTT-50506), reducing the number of single-family residential lots from 76 to 65 with two common area lots (for open space/landscaping and water quality basin) for a total of 67 lots, on an approximately 64 acre site in the [T]RE20-1, OS-1XL zones.

REQUESTED ACTION: The Deputy Advisory Agency will consider:

1. Pursuant to the Los Angeles Municipal Code Sections 17.03 and 17.11, a Modification (VTT-50506-M1) to a previously approved Vesting Tentative Tract Map (VTT-50506) for

the construction, use, and maintenance of 65 single-family homes and two open space lots in the [T]RE20-1, OS-1XL zones.

2. Find under the California Public Resources Code Section 21166 and the State's Environmental Quality Act (CEQA) Guidelines Section 15162, on the basis of substantial evidence contained in the whole record, that since certification of EIR No. 88-0026(SP)(ZC)(GPA), as updated by addendums dated April 2000, September 2000 and October 2006, there have been no changes to the project, changes with respect to the circumstances under which the project is being undertaken, or new information of substantial importance concerning the project, which cause new significant environmental effects or a substantial increase in the severity of previously identified significant effects, and therefore no additional environmental review is required for the project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

ADVICE TO PUBLIC: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
