PROJECT LOCATION: 11320 and 11322 La Grange Avenue

PROPOSED PROJECT: The construction, use and maintenance of two residential condominium units on a **9,148 6,488.4** net square-foot (0.~~21.15~~ acre) site.

REQUESTED ACTION: The Deputy Advisory Agency will consider:

1. Pursuant to the Los Angeles Municipal Code Section 17.50, Parcel Map No. AA-2015-2896-PMLA to permit the construction, use and maintenance of two residential condominium units on a net **9,148 6,488.4** square-foot site in the R2-1 Zone;
2. Pursuant to the Los Angeles Municipal Code Section 17.53-J, an adjustment to

allow for a reduced lot width of 49.75 feet in lieu of the 50 feet otherwise required by LAMC Section 12.09,C-4, and a 3-foot northerly side yard on in lieu of the 6-feet otherwise required by LAMC Section 12.09,C-2; and

3. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall, therefore, be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
