PROPOSED PROJECT: Modification of Final Recorded Tract Map No. 61917 to revise the amount of permitted commercial floor area from 224,700 square feet to 230,400 square feet.

REQUESTED ACTION: The Deputy Advisory Agency will consider:

1. Pursuant to Section 17.14 of the Los Angeles Municipal Code, a Modification of a Final Recorded Tract Map to revise the amount of commercial floor area from 224,700 square feet to 230,400 square feet; and
2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and shall, therefore, be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
