PROJECT LOCATION: 1674 W. 186th Street and 18620 S. Western Avenue

PROPOSED PROJECT: The sale and dispensing of beer and wine for on-site consumption in conjunction with a new restaurant (Denny's) in an existing 3,065 square foot commercial building with 117 indoor seats, and 24 outdoor seats within a 459 square foot patio, open 24 hours a day Monday through Sunday, with proposed alcohol sales from 10:00 a.m. to 2:00 a.m. daily, and including up to two (2) video game machines, on a 34,193 square foot lot with 59 parking spaces. Only tenant improvements are proposed; no addition of floor area will result.

REQUESTED ACTION: 1) Pursuant to Section 12.24-W,1 of the Los Angeles Municipal Code (LAMC), a Conditional Use to permit the sale and dispensing of beer and wine for on-site consumption in conjunction with a new restaurant in the C2-1 and P-1VL Zones;

- 2) Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall, therefore, be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
