REQUESTED ACTION: The Zoning Administrator will consider:

1. Pursuant to Los Angeles Municipal Code Section 12-24-W,27, a Conditional Use Permit authorizing: the continued operation and maintenance an existing 24-hour, daily, gas station, and the proposed construction, operation and maintenance of a 1,835 square-foot, 24-hour, daily, convenience store, in lieu of the 7 a.m. to 11 p.m. otherwise permitted; zero transparent doors and no window on the eastern elevation of the proposed convenience store building, in lieu of the 50% transparency otherwise required by Section 12.22-A,23(a)(3); and partial landscaping along the Western Avenue property line and zero landscaping along the Slauson Avenue property line, in lieu of a landscaped, planted area having a minimum inside width of 5 feet along all street frontages and on the perimeters of all parking areas of the property which abuts residential zone or use otherwise required by Section 12.22-A,23(a)(10)(i); all in conjunction with the subject gas station on a total 14,516 square-foot property, in the [Q]C2-1 Zone.

2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

Advice To Public: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
