REQUESTED ACTION: The Zoning Administrator will consider:

1. Pursuant to provisions of Section 12.20.2 of the Los Angeles Municipal Code, a Coastal Development Permit authorizing the demolition of an existing single-family dwelling and the construction, use, and maintenance of a new 33-foot tall, 5,800 square-foot, single-family dwelling with an attached 784 square-foot garage, 3,100 square-foot basement, 440 square feet of covered areas, cabana, swimming pool, and two retaining walls on an 11,897 square-foot lot in the R1-1 Zone within the dual-jurisdiction area of the California Coastal Zone; A Mello Act Compliance Review for the proposed demolition of an existing single-family dwelling and construction, use, and maintenance of a new single-family dwelling; and Pursuant to provisions of Section 12.24-X,28 of the Los Angeles Municipal Code, a Zoning Administrator's Determination authorizing a reduced front yard of 5 feet in lieu of the 17 feet 6 inches otherwise required by Section 12.21-C,10(a).

2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

<u>Advice To Public</u>: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
