REQUESTED ACTION: The Zoning Administrator will consider:

- 1. Pursuant to the provisions of Section 12.28 of the Los Angeles Municipal Code, a Zoning Administrator's Adjustment to permit a carport and detached recreation room to observe a 0-foot sideyard setback in lieu of the 5-foot side yard required by Section 12.08, and a rear yard of 4 feet 6 inches in lieu of the 5-foot rear-yard required by Section 12.21-C,5(e), all in conjunction the conversion of a detached carport into a recreation room and construction of a new carport in the R1-1 Zone.
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
