The representative for the applicant gave a presentation in support of the appeal and requested extended hours of operations for a 7-Eleven convenience store. Several speakers spoke against the project. .

Several testimonies were heard during the public comment period. Rebuttal time was given to the applicant's representative. The Commissioners asked clarifying questions of the applicant's representative. A delegate from Council District 15 spoke in regards to the Councilmember's support of the appeal with specific conditions agreed upon between the Councilmember and Los Angeles Police Department [LAPD]. Testimony was given of how the Councilmember and LAPD were excited to have a stable tenant that would have resources and be an accountable business operator. Commissioner Willis closed the public comments period and asked for last remarks from the City Planner.

The Commission deliberated and formed a motion.

Grant the appeal in part, to modify the conditions of approval; sustain the decision of the Zoning Administrator to approve the Conditional Use permit to allow 24 hours operations of the 7-Eleven convenience store along with conditions of approval; to permit less than the required minimum 50 percent transparent windows of exterior walls facing adjacent streets otherwise required by Section 12.22-A,23(a)(3); and to permit a landscaped setback less than the minimum 5 feet landscape setback otherwise required by Section 12.22-A,23(a)(10)(i). Adopt the amended findings of the Zoning Administrative and Adopt Mitigated Negative Declaration No. ENV-2014-4309-MND.
