- 1. Pursuant to the provisions of Section 12.24-X,28 of the Los Angeles Municipal Code, a Zoning Administrator's Adjustment to permit 5-foot side yards in lieu of the 10-foot side yard required by Section 12.07.01-C,2(b); and Pursuant to LAMC 11.5.7, a Project Permit Compliance per the Mt. Washington/Glassell Park Specific Plan for the construction of a new 41-foot tall, 3,210 square-foot residence on a 7,162 square-foot lot zoned RE20-1.
- 2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.
