**REQUESTED ACTION:** The Zoning Administrator will consider:

- 1. Pursuant to the provisions of Section 12.28 of the Los Angeles Municipal Code, a Zoning Administrator's Adjustment to permit a rear yard varying between 1-foot and 5 feet in lieu of the 15-foot rear yard required by Section 12.09-C; and Pursuant to Section 11.5.7 of the Code, a Project Permit Compliance from the Venice Coastal Zone Specific Plan to permit the addition and renovation to an existing dwelling unit sited on a lot zoned R2-1.
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision
