REQUESTED ACTION: The Zoning Administrator will consider:

- 1. Pursuant to the provisions of Section 12.28 of the Los Angeles Municipal Code, a Zoning Administrator's Adjustment to 1) Permit a front yard of 17 feet 6 inches in lieu of the 18-foot 7-inch front yard setback required by Section 12.08-C,1; 2) Permit a side yard of 3 feet 2 inches along the easterly property line in lieu of the 4-foot side yard setback required by Section 12.08-C,2; 3) Permit a rear yard of 13 feet in lieu of the 15-foot rear yard setback required by Section 12.08-C,2, and 4) Permit a floor area of 2,281 square feet in lieu of the maximum 2,105 square feet allowed by Section 12-08,C-5, all in conjunction with the construction of a new single-family home on a vacant 3,240 square-foot lot zoned R1-1.
- Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has 2. been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
