REQUESTED ACTION: The Zoning Administrator will consider:

1. Pursuant to Los Angeles Municipal Code Section, 12.24 M, Approval of Plans to allow the sale and dispensation of a full line of alcoholic beverages for on-site consumption in conjunction with a 2,920 sq. ft. bar/lounge located in the basement with live entertainment (no dancing) with indoor seating for approximately 122 patrons with hours of operation from 11:30 a.m. to 2:00 a.m. daily.
