**PROJECT LOCATION:** 7265 West Melrose Avenue

**PROPOSED PROJECT:** Change of use from retail to a 3,960 square-foot restaurant with 179 seats and sidewalk dining in the C4-1XL Zone.

**REQUESTED ACTION:** The Zoning Administrator will consider:

1. Pursuant to Charter Section 562 and Los Angeles Municipal Code Section 12.27, a Zone Variance to allow relief from the following:
  - a. Los Angeles Municipal Code Section 12.21-A,4(c)(3) to permit zero (0) on-site parking spaces in lieu of 32 required parking spaces, with required parking to be provided off-site through a valet parking program;
  - b. Los Angeles Municipal Code Section 12.26-E,5 to permit the code-required parking to be provided through lease rather than covenant;
  - c. Los Angeles Municipal Code Section 12.21-A,4(g) to allow flexibility in the valet parking program to park vehicles at a location over 750 feet from the subject site; and

2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Negative Declaration (ND) for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
