## **ACTIONS:**

- 1. Pursuant to Section 17.50 of the Los Angeles Municipal Code (LAMC) consideration of a Preliminary Parcel Map.
- 2. Pursuant to Section 17.53-J of the LAMC, consideration of a **Zoning Administrator Adjustment** from Section 12.09.1-B.4 to allow a reduced lot area of 4,800 square feet in lieu of the required 6,000 square feet.

- 3. Pursuant to Section 17.53-J of the LAMC, consideration of a **Zoning Administrator Adjustment** from Section 12.09.1-B.4 to allow a reduced lot width of 55 feet in lieu of the required 60 feet.
- 4. Pursuant to Section 17.53-J of the LAMC, consideration of a **Zoning Administrator Adjustment** from Section 12.09.1-B.2,(b) to allow a reduced side yard setback of 4.4 feet in lieu of the required 5.5 feet.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
