REQUESTED ACTION: The Zoning Administrator will consider:

- 1. Pursuant to Los Angeles Municipal Code Section 12.28-A, a Zoning Administrator's Adjustment to allow the construction, use, and maintenance of a retaining wall and perimeter fence with a maximum height of 10 feet along the south, east, and west property lines for Tract 72510 in lieu of the maximum 6 feet otherwise permitted in the side and rear yards by Section 12.22-C,20(f) of the Code, in conjunction with the development of a 24-lot single-family residential subdivision located on a 2.55-acre site in the (T)(Q)RD3-1-RIO and (T)(Q)R1-1-RIO Zones.
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
