REQUESTED ACTION: The Zoning Administrator will consider:

- 1. A Zoning Administrator's Determination, pursuant to the provisions of Section 12.24-M of the Los Angeles Municipal Code, for an Approval of Plans to modify Condition No. 9. of Case ZA 95-0724(CUB)(PA5) to allow an expansion of hours of operation from 11 a.m. to 12 midnight Sunday through Wednesday and 11 a.m. to 1 a.m. Thursday through Sunday, to: Open 9 a.m. Saturday and Sunday, 11 a.m. Monday through Friday; Close 1 a.m. Sunday through Wednesday and 2 a.m. Thursday through Saturday, for an existing 7,104 square-foot restaurant, with 271 interior and 48 exterior seats within a regional shopping center.
- 2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record.
