**PROJECT LOCATION:** 1408 and 1410 N. Poinsettia Place

**PROPOSED PROJECT:** Demolition of two single family dwelling units, and the construction of 5 new small-lot dwellings, each with 2-car spaces, for a total of 10 automobile parking spaces will be provided. The units will be within a maximum height of approximately 45 feet, on an approximate 6,248 square foot site in the R3-1 Zone.

**REQUESTED ACTION:** The Deputy Advisory Agency will Consider:

1. Pursuant to the Los Angeles Municipal Code Section (LAMC) 17.15 and 12.22-C, 27, Vesting Tentative Tract Map No. 73726-SL to permit the subdivision of one rectangular shaped parcel into 5 small lots pursuant to Ordinance No. 176,354 (small lot subdivision) in the R3-1 Zone, on 0.143 net acres;
2. Pursuant to Section 17.03-A Los Angeles Municipal Code, a Zoning Administrator's Adjustment to permit a 3-foot reduction (20 percent) from the required 15-foot front yard;

3. Pursuant to Section 21082.1(c)(3) of the California Public resources Code, adopt the Mitigated Negative Declaration (ENV-2015-3586-MND) for the above referenced project; and
4. Pursuant to Section 21081.6 of the California Public Resources Code, adopt the Mitigation Monitoring Program for ENV-2015-3586-MND.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

**EXHAUSTION OF ADMINISTRATIVE REMEDIES:** If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
