REQUESTED ACTION: The Zoning Administrator will consider:

- 1. Pursuant to the Los Angeles Municipal Code Section 12.24-W, 1, a Conditional Use Permit to allow the sale and dispensation of a full line of alcoholic beverages for on-site consumption in conjunction with a proposed 1.850 sq. ft. restaurant with indoor seating for 52 patrons and a 95 sq. ft. outdoor seating area along the public right-of-way for 12 patrons.
- 2. Pursuant to the Los Angeles Municipal Code Section 12.24-W, 27, a Conditional Use Permit to allow the proposed restaurant hours of operation to be 7:00 a.m. to 2:00 a.m. daily in lieu of those permitted for mini-shopping centers adjacent to residentially zoned properties.
- 3. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
