PROJECT LOCATION: 1304 and 1308 North Mansfield Avenue

PROPOSED PROJECT: The construction, use, and maintenance of 4 Small Lot homes on a net 6,466 square-foot lot. Two single-family homes will be demolished and three non-protected trees will be removed as part of the project.

REQUESTED ACTION: The Deputy Advisory Agency will consider:

1. Pursuant to the Los Angeles Municipal Code (LAMC) Sections 17.53 and 12.22-C,27 to permit the subdivision of 4 small lots in conjunction with the construction of 4 new small lot homes with 8 parking spaces in accordance with the Small Lot Ordinance No. 176,354 in the R3-1XL Zone;
2. Pursuant to Section 17.53-J of the LAMC, a 12 percent adjustment to allow a height of 33 feet, 6 inches in lieu of the otherwise maximum height of 33 feet; and

3. Pursuant to Sections 21082.1(c)(3) and 21081.6 of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) and the Mitigation Monitoring Program (MMP), respectively, for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

EXHAUSTION OF ADMINISTRATIVE REMEDIES: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
