PROJECT LOCATION: 17985 W Pacific Coast Highway, legally described as: Lot Pt Allotment No 3 to Pascual Marquez, Rancho Boca De Santa Monica Tract

PROPOSED PROJECT:

The proposed project reconfigures a portion of an existing driveway and associated landscaping within the Getty Villa property to incorporate a shuttle van turnaround area, with a retaining wall not to exceed four feet in height. The total project area is 5,735 square feet. The project will include native, drought tolerant landscaping and a new

bioswale, in the dual permit jurisdiction area of the Coastal Zone.

REQUESTED **ACTION:**

1. Pursuant to Section 12.20.2 of the Municipal Code, a Coastal Development Permit for the proposed project to reconfigure a portion of an existing driveway and associated landscaping within the Getty Villa property. The project will include a new shuttle van turnaround area, native, drought tolerant landscaping with a new bioswale and a retaining wall not to exceed four feet in height. The

total project area is 5,735 square feet, and is located in the dual permit jurisdiction area of the Coastal Zone.

2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of the California Environmental Quality Act (CEQA). Pursuant to Article III, Section I, Class 1, Category 1 of the City of Los Angeles CEQA Guidelines.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.
