REQUESTED ACTION: The Zoning Administrator will consider:

1. Pursuant to Section 12.24-X,28 of the Los Angeles Municipal Code, a Zoning Administrator's Determination to allow for the construction, use, and maintenance of a new, 44-foot 6-inch, 1,989 square-foot single-family dwelling on a hillside lot fronting a Substandard Hillside Limited Street having a roadway width of less than 20 feet as otherwise required by Section 12.21-C,10(i)(2), and which does not have vehicular access from a street with a minimum 20-foot continuous paved roadway from the driveway apron to the boundary of the hillside area as otherwise required by Section 12.21-C,10(i)(3); and, Pursuant to Section 11.5.7, a Specific Plan Project Permit Compliance for the Mount Washington/Glassell Park Specific Plan to allow for the construction of said home.
2. Pursuant to Section 21082.1(c)(3) of the California Public Resources Code, adopt the Mitigated Negative Declaration (MND) for the above referenced project.

The purpose of the hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion Of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.

Advice To Public: The exact time this report will be considered during the meeting is uncertain since there may be several other items on the agenda.
