PROPOSED PROJECT:

The proposed project involves the demolition of a 1,376 square-foot, one-story single-family dwelling and two-car garage, and the construction of a 3,471-square-foot, three-story, single-family dwelling, with a 416 square foot two-car garage and one car carport with a studio above at 416 square feet, with a maximum building height of 41.33 feet, located in the single permit jurisdiction area of the Coastal Zone.

REQUESTED ACTION:

1. Pursuant to Section 12.20.2 of the Municipal Code, a **Coastal Development Permit** for the proposed demolition of a 1,376 square-foot, one-story single-family dwelling and two-car garage, and the construction of a 3,471-square-foot, three-story, single-family dwelling, with a 416 square foot two-car garage and one car carport with a studio above at 416 square feet, with a maximum building height of 41.33 feet, located in the single permit jurisdiction area of the Coastal Zone.

Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of the California Environmental Quality Act (CEQA).
