REQUESTED ACTION: The Zoning Administrator will consider:

- 1. Pursuant to Section 12.24–M, of the Los Angeles Municipal Code, a Zoning Administrator's determination for an Approval of Plans to extend the term grant beyond the five years previously approved under ZA Case No. 2007-2930(CUB)(CUX)(ZV)(PA1) in conjunction with the continued sale and dispensing of a full line of alcoholic beverages for on-site consumption in conjunction with a 9,466 square-foot restaurant and bar and 2) the modification of Condition No. 22 of Case No. 2007-2930(CUB)(CUX)(ZV) to remove the prohibition of admission/cover charge and to allow there be a requirement to purchase a minimum number of drinks requirement per person.
- 2. Pursuant to Section 21084 of the California Public Resources Code, the above referenced project has been determined not to have a significant effect on the environment and which shall therefore be exempt from the provisions of CEQA.

The purpose of this hearing is to obtain testimony from affected and/or interested persons regarding this project. The environmental document will be among the matters considered at the hearing. The decision maker will consider all the testimony presented at the hearing, written communication received prior to or at the hearing, and the merits of the project as it relates to existing environmental and land use regulations.

Exhaustion of Administrative Remedies: If you challenge a City action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence on these matters delivered to the Department before the action on this matter will become a part of the administrative record. Note: This may not be the last hearing on this matter.
